WHEREAS:



4. On July 3, 2008, the parties filed a fully executed stipulation settling this matter; and


5. The parties' stipulation of settlement provides that the Petitioner withdraws the petition with prejudice; and

7. The Board approves petitioner's withdrawal of the petition.


NOW, THEREFORE, IT IS HEREBY RESOLVED THAT:
