WHEREAS:



Pursuant to Labor Law § 101 and Part 66 of the Industrial Board of Appeals' Rules of Procedure and Practice (Rules) (12 NYCRR Part 66), the above proceeding was commenced on December 18, 2007 by the filing of a petition to review an order that the Commissioner of Labor (Commissioner) issued against the Petitioner on October 19, 2007; and
2. The Commissioner filed an answer to the petition on January 18, 2007; and
3. The parties participated in a pre-hearing telephone conference held on behalf of the Board on April 9, 2008; and
4. On June 23, 2008, the parties filed a fully executed stipulation settling this matter; and

- 5. The parties' stipulation of settlement provides that by executing the stipulation, the Petitioner withdraws the petition with prejudice; and
- 6. Rule 65.15 provides that at any stage of a proceeding, a party may withdraw the petition with the Board's approval; and
- 7. The Board approves the petitioner's withdrawal of the petition.


NOW, THEREFORE, IT IS HEREBY RESOLVED THAT:
