Under the supervision, control and critique of the Regional Director of Soccer Programs, the Soccer Instructor conducts soccer activities with groups in public, private, or volunteer agencies or recreation facilities. Organizes, facilitates and promotes soccer activities, taking into account the needs and interests of individual members, in camp settings, childcare facilities, afterschool programs and soccer organizations. Minimum Requirements: Associate's degree in physical education, sport and leisure, or related area of study OR soccer (European football) coaching license. No on the job training available. Successful applicant must pass police background check. Salary: \$14.48/hour, 35 hours/week, Mon-Fri, 3-9pm, and Sat 8am-1pm. No OT available. Employee is responsible for personal housing and transportation to various worksites (athletic fields) within Nassau and Suffolk Counties with reimbursement at \$25/week for mileage over 300 miles/week. Any unexpected job-related expenses incurred by employee (ie, tolls, flat tire) will be reimbursed 100% to employee. Auto and insurance (max deduction \$100/week) and housing (max deduction \$80/week), health insurance (max deduction \$15/week) can be arranged at the employee's expense, if requested. Up to \$15/week commission possible. Employer will make all payroll deductions required by law. Employer will use a single workweek as its standard for computing wages due. Wages paid weekly on Friday. Employer will provide or reimburse for transportation and daily travel subsistence expenses that are incurred from the place from which the worker has come to work, to the place of employment if the worker completes 50% of the work contract. Employer will provide or reimburse for the worker's cost of return transportation and daily travel subsistence from the place of employment to the place from which the worker came, if the worker completes the work contract or is dismissed from employment before the end of the work contract. Daily subsistence will be provided at a rate of \$11.86 per day during travel to a maximum of \$46.00 per day with receipts. All tools, supplies and equipment provided by employer without charge or deposit charge. Employer guarantees to offer employment for a total number of work hours equal to at least 75% of the workdays in every 12-week period. Employer will reimburse an H-2B worker in the first work week for all visa, visa processing, border crossing, and other related fees, including those mandated by the government, incurred by the H-2B worker (excluding passport fees).
